
Aquila Fund FCR is a **Portuguese investment platform** comprising four fully independent investment funds registered with the CMVM.

The Golden Visa is a residency program in European Union countries through investments.

By investing in Portugal, individuals are granted the right to reside in the country, with access to education for the entire family, healthcare, and other rights available to permanent residents.



Benefits of the Portuguese Golden Visa

- Residency, Education, and Employment: The right to live, study, and work in Portugal for you and your family.
- Schengen Area Access: Visa-free entry to Portugal and the entire Schengen Area, encompassing 27 European countries.
- Path to Permanent Residency and Citizenship: Apply for permanent residency or Portuguese citizenship after 5 years.
- Minimal Stay Requirement: Only 7 days of residence per year are required.
 - No Personal Tax Impact: Golden Visa holders are not subject to personal tax obligations solely due to their visa status.

Private Equity Market Trends in 2024

Portugal's private equity market continues to grow. In 2023, 84 private equity transactions were recorded, totaling €1.4 billion, representing a 27% increase compared to 2022.

Sector-Specific Insights

In Q1 2024, cleantech investment across
Europe remained stable, with €2.8 billion
directed toward venture and growth capital.
There was a rise in late-stage deals,
indicating increasing interest in scaling
companies.

Portugal is home to a thriving biotech investment community. As of December 2024, key investors included Portugal Ventures (10 investments) and Caixa Capital (6 investments), demonstrating strong support for biotech startups in the country.

Emerging Companies: Portugal has become a hub for healthtech innovation. As of February 2025, 12 prominent companies were actively developing cutting-edge solutions to enhance healthcare, highlighting growth and innovation in the sector.

The Secondary Market

The secondary market in private equity is a specialized platform that facilitates the buying and selling of ownership stakes in established private equity funds or portfolios of privately held companies.

Unlike primary investments, which involve new commitments to early-stage opportunities, the secondary market focuses on mature investments that have already demonstrated performance, providing greater visibility into returns, cash flows, and risk profiles.


